More to come on this as we move into the new year. The goals of UMOJA are relevant because of the racial unrest issues currently plaguing our society. One of their goals is to focus on anti-racism at the College of Marin toward a better tomorrow. They noted that Marin has the most segregated sections in the state of California. They would like to work with the high schools as well as the faculty and staff at COM. Equity, mental health and psychological services also play a big role in their work.

They also realize that the Classified Professionals are often the students first contact with COM. They would like their involvement with our Classified Professionals to grow and build on the success while growing with faculty. They are hoping that we can provide training skills on diversity to provide upward mobility. They would like to bring all resources together to achieve their goals. Connie asked how she could move their goals forward. Monica asked if we are empowering people to know their worth. Colleen replied yes and that faculty brings this into the classroom. UMOJA has an informal mentoring program that the would like to make more formal. They would also like to have students learn from each other.

Walter acknowledged and thanked Kim for her support of UMOJA's fundraising efforts. As a result of Kim's generosity, UMOJA was able to utilize the theater as a fundraising venue.
