Monica and Maridel both graciously offered to again lead their Sessions on Meditation and Social Hours. Connie graciously offered to work with Maridel and Monica to prepare the survey.

It was agreed that the survey was a good idea and the Classified Senate would offer the same activities as last year while giving the Classified Professionals the opportunity to lead a class and/or suggest a class that is new to our current offerings.

Maridel offered to research the possibility of earning points for our volunteer efforts.
