Agenda Motion to approve agenda. Motion approved.

<u>Minutes</u> Motion to approve January 29, 2021 meeting minutes. Motion approved.

Events and Calendar Planning for 2021 Classified Senate Calendar. Activity Planning for Classified Staff. Meditate, Stretch and Relax, Zoom Social Hour, Trivia Game, Book Club next date is 2/22/21.

Guest Presentation Gina Cullen: Guided Pathways Self-Assessment. Highlights include progress on interest cluster and discipline website pages; and building out a STEM learning community; and offering ESL & SAS counseling classes. The report also highlights outreach to students, including calling students on probation/dismissal status and those close to transfer. Intentional efforts to target first generation students close to transfer or degree were also highlighted. Significant revisions to Program Review template were mentioned. Next steps in the report include: developing a roadmap for interest clusters; evaluating effectiveness of pilot companion courses related to implementation of AB705; and need for more professional learning. Software to asynchronously reach out to students is under consideration. COM has been accepted into Cohort 2 of the CA Guided Pathways Project. That project brings together community colleges to share experiences related to guided pathways and equity. The AS conducted an informal poll on approving the report and the sense of the body was to move it forward for approval. Report approval will be on the Consent Agenda for the next AS meeting. The request was made to have Gina return to the Classified Senate in 3-4 months for an update on the continued progress of Guided Pathways. MB, GC

Holley Shafter: Mid-Term Accreditation Report Update. The accreditation Report was done in 2017. There was a 2018 follow up report and now we are at the 2021 mid-term report. Highlights include improvements made on removing barriers for students in English and Math. Hiring process tracking has shown an improvement in the diversity of faculty and employee representatives being more reflective of the student population. The improvement is credited to efforts made to remove barriers to employment through reevaluating minimum qualifications that were not imperative to the job as well as an effort to reach a more diverse population when advertising available jobs.

Committee Reports President's Report. Covid-19 Oversight Committee update. Going forward, the Implementation Team will review future proposals for in-person activities, gather information to evaluate the proposal, and send the proposal with recommendations to the Oversight Team for final approval.

Treasurers Report. No changes, current funds at \$2,026.32.
